The Board of Directors, during its Special Board Meeting held today, approved the following items:

- A. Approval of the public offer and issuance of additional Series 4 preferred shares of up to 17 million shares as the second tranche of the Series 4 preferred shares to be taken down from the shelf registration rendered effective by the Securities and Exchange Commission MSRD Order No. 33, Series of 2023, with features to be determined by Management, including (where required) the conduct of a written assent solicitation from stockholders with a record date of July 10, 2024 and closing of books from July 10-17, 2024;
- B. Redemption of the Series 3A preferred shares, with a record date of November 21, 2024; and
- C. Request for extension of the shelf registration of up to \$\mathbb{P}\$50 billion worth of peso fixed-rate bonds.
